Part of the final approach track to Rwy 23 Boscombe Down, passes through the lateral limits of the Thruxton ATZ. During CMATZ hours of operation, acft being provided ATS by Boscombe Down will transit the Thruxton ATZ above 1450ft AAL. Recommended arrival/departure with the intent of avoiding traffic above 1450ft AAL. Extensive military helicopter and jet operations can be anticipated at any time in the vicinity of Thruxton ATZ.

Authorised acft movements may take place outside notified AD/ATZ operating hours involving acft that do not require use of a licensed aerodrome.

Two large birds of prey are released daily at 1430 (1330) from London Hill, approximately 800m southeast of Rwy 30 thld. Pilots are requested to avoid the area during this activity. A/G will notify when the activity is completed.



No dead side on Rwy 07/25 due to Helicopters on south side.

Rwy 07/25 - Downwind leg must be to the north of Kimpton village and the large new house.

Noise Abatement Procedures:

The nominal circuits shown are to be flown to avoid noise sensitive areas.

All departures from Rwy 07 should turn right at the aerodrome boundary to maintain a track of 080°M until clear of Fyfield village.
