

EASTCHURCH AIRFIELD Noise Abatement and Circuits



Noise Abatement Procedures

Eastchurch Airfield is surrounded by noise sensitive areas and we would ask that all pilots familiarise themselves fully with the noise abatement procedures and follow them.

Departures

Runway 08:

As soon as safely possible make a slight right turn to avoid Eastchurch Village also please avoid overflying surrounding houses Climb to at least 600ft AAL before turning crosswind. Continue climbing to 1000ft AAL before turning either downwind or departing the circuit.

Runway 26:

As soon as safely possible make a slight left turn to avoid the white house on the end of the runway (no overfly.)

Continue turning left (avoiding HMP prison cluster and Wind turbines) heading 220° to at least 1000ft AAL before turning either downwind or departing the circuit.

Arrivals

Runway 08:

The Final Approach is offset by approx. 30° (as per map) Please avoid over flying any houses on final approach especially the white house on the extended centre line of the runway

Runway 26:

Final Approach is offset by approx. 30° (as per map)

Please avoid over flying any houses on the Final Approach - you should end up just South of the roundabout before turning onto runway heading just before the threshold.
