# Microlight Pilot's Logbook

## INSTRUCTIONS FOR USE

1. This log book must be kept accurately and up-to-date, it is an important legal document.
2. Every flight in which the holder is part of the crew of a microlight aircraft must be recorded in this logbook, using one line per flight.
3. The take-off time is the time of "brakes-off" before flight, the landing time is the "brakes-on" time.
4. All times should be given in Greenwich Mean Time (also known as Zulu or UTC).
5. Where two qualified pilots 'share' captaincy for a flight, the changeover time must be agreed and the time for which the holder is not captain may only be recorded in the column Passenger (interest only).
6. Where the holder is flying as a student under supervision of an AFI or FI, the entry must show exercise numbers and be countersigned by the instructor with his/her qualification number.
7. Any other required information can be recorded in the remarks column.
